On 18 July 2024, V2Y Corporation Ltd. (the "Company") had entered into a placement agreement with Ang Wei Yang Felix, Muhammad Asyraf Bin Azman ("Asyraf") and Teng Jun Jie ("TJJ") where amongst others, Asyraf and TJJ are to extend a convertible loan facility. On 24 September 2024, the Company had submitted drawdown notices to Asyraf and TJJ to draw down a total convertible loan amount of S\$900,000. The Company has on 30 September 2024 issued and allotted 60,810,810 shares in aggregate to Asyraf and TJJ as repayment of the convertible loan amount.

The shareholding percentage before the change are calculated based on the total number of 387,669,692 ordinary shares (excluding treasury shares).

The shareholding percentage immediately after the allotment is calculated based on 448,480,502 ordinary shares (excluding treasury shares).
