As required by Rule 1207(12) of the Listing Manual, please make disclosures as recommended in the Code of Corporate Governance 2012 (the "Code") or otherwise explain the reason(s) for the deviation from the following Code recommendation: -

Paragraph 9.3 of the Code states that the Company should name and disclose the remuneration of at least the top five key management personnel (who are not directors or the CEO) in bands of S\$250,000. We note that the Company disclosed the upper band for Key Executives as "above S\$250,000", without an upper bound. Please make the requisite disclosure in accordance with the Code.
