

- 2) FHT Australia Management Pty Ltd nominated FCLI to receive 2,146,720 Stapled Securities issued as payment of management fees in respect of FHT Australia Trust (the "MIT");
- 3) FHPL nominated FCLI to receive 2,227,459 Stapled Securities issued as payment of serviced residence fees in respect of the non-UK properties of FH-REIT; and
