FOURTH ISSUANCE OF PROPOSED ISLAMIC MEDIUM TERM NOTES PROGRAMME OF UP TO RM500 MILLION IN NOMINAL VALUE BASED ON THE SHARIAH PRINCIPLE OF WAKALAH BI AL-ISTITHMAR (“SUKUK WAKALAH PROGRAMME”) BY JB COCOA SDN BHD

The board of Directors (the “Board”) of JB Foods Limited (the “Company”) together with its subsidiaries (the “Group”) refers to the Company’s announcement on 23 August 2022, 30 November 2022, 14 November 2023, 30 November 2023 and 18 March 2024 (“Previous Announcements”).

The Board is pleased to announce that the fourth issuance of Sukuk Wakalah under the Sukuk Wakalah Programme by JB Cocoa Sdn Bhd is scheduled to take place on 13 November 2024, based on the salient terms summarised below:

Utilisation of Proceeds	The proceeds raised from the fourth issuance of Sukuk Wakalah under the Sukuk Wakalah Programme shall be utilised for the Shariah-compliant purposes of the Issuer, and the Company and its subsidiaries: (i) to fund capital expenditures; (ii) to refinance existing financing or borrowings; (iii) to fund working capital requirements; and (iv) to fund other corporate purposes, all of which shall be Shariah-compliant.
