ANNOUNCEMENT ISSUE AND LISTING OF NEW UNITS UNDER THE DISTRIBUTION REINVESTMENT PLAN

Further to the announcements dated 24 July 2024, 1 August 2024, 8 August 2024 and 20 August 2024, Mapletree Logistics Trust Management Ltd., as manager (the “**Manager**”) of Mapletree Logistics Trust (“**MLT**”), wishes to announce that it will issue 12,959,906 new units in MLT (“**Units**”) at an issue price of S\$1.276 per Unit pursuant to MLT’s distribution reinvestment plan (“**DRP**”) in respect of MLT’s distribution for the period from 1 April 2024 to 30 June 2024 (the “**1Q FY24/25 Distribution**”) on 18 September 2024.

The new Units will be credited by 18 September 2024 to securities accounts of MLT unitholders (“**Unitholders**”) who have elected to participate in the DRP. The new Units will commence trading on the Main Board of Singapore Exchange Securities Trading Limited at 9.00 a.m. on 18 September 2024.

The new Units will rank pari passu in all respects with the existing Units.

Following the issuance of the new Units, the total number of MLT Units has increased from 5,033,288,600 to 5,046,248,506.

Unitholders who did not elect or partially elected to participate in the DRP and overseas Unitholders who did not provide registered mailing addresses in Singapore to The Central Depository (Pte) Limited, will receive their respective entitlements to the 1Q FY24/25 Distribution in cash on 18 September 2024.
