23 JANUARY 2026 ("EGM")**

RAFFLES EDUCATION LIMITED (the "Company") is pleased to announce, in accordance with Clause 704(15) of the Listing Manual of the Singapore Exchange Securities Trading Limited, that all the resolutions as set out in the Notice of Extraordinary General Meeting ("EGM") dated 8 January 2026 were put to, and duly passed, by poll vote at the EGM which was held on 23 January 2026.

A. Breakdown of all valid votes cast at the EGM

Mr. Chew Hua Seng and his associates, who collectively hold an aggregate of 525,812,764 shares in the Company, abstained from voting on the resolution in relation to the Proposed Conversions in respect of an aggregate of 440,384,766 shares, and did not cast any vote in respect of the remaining aggregate of 85,427,998 shares.

Mr. Chew Hua Seng, parties acting in concert with him and parties not independent of them, who collectively hold an aggregate of 525,812,764 shares in the Company, abstained from voting on the Proposed Conversions Whitewash Resolution and the CHSCP Scrip Dividend Whitewash Resolution in respect of an aggregate of 440,384,766 shares, and did not cast any vote in respect of the remaining aggregate of 85,427,998 shares.
