## ANNOUNCEMENT PURSUANT TO RULE 706A OF THE CATALIST RULES

The Board of Directors (the "**Board**") of Accrelist Ltd. (the "**Company**", and together with its subsidiaries, the "**Group**") wishes to announce that the following transactions that occurred during the financial period ended 30 September 2020 and up to the date of the announcement, pursuant to Rule 706A of the SGX-ST Listing Manual Section B: Rules of Catalist:-

### A. ACQUISITION OF ADDITIONAL SHARES IN WE COMPONENTS SDN BHD

The Company had on 13 August 2020 acquired an additional 150 ordinary shares in the share capital of WE Components Sdn Bhd from Ms Chim Poh Yee at a cash consideration of RM1.00 (the "**Acquisition**"), on a willing-buyer and willing-seller basis.

The changes in equity interests in WE Components Sdn Bhd before and after the Acquisition are as follows:

The Acquisition is not expected to have any material impact on the net tangible asset per share and earnings per share of the Group for the current financial year ending 31 March 2020.

Saved as disclosed for the above, none of the directors, substantial shareholders or controlling shareholders of the Company has any interests in the above transaction, other than their shareholding interest in the Company.

### B. INCREASE IN PAID-UP CAPITAL OF AN INDIRECT WHOLLY-OWNED SUBSIDIARY, JUBILEE INDUSTRIES (S) PTE. LTD.

Jubilee Industries Holdings Ltd. ("**JIH**"), the subsidiary of the Company had on 30 September 2020 increased the issued and paid-up share capital of its wholly-owned subsidiary, Jubilee Industries (s) Pte. Ltd. by way of allotment and issuance of 13,600,000 ordinary shares in the share capital of Jubilee Industries (S) Pte. Ltd., for a total aggregate consideration of S\$13,600,000 by way of capitalisation of loan.

None of the Directors or substantial shareholders of the Company have any interest, directly or indirectly, in the allotment and/or capitalisation of the loan, save for their respective shareholdings in the Company.

**C. INCREASE IN PAID-UP CAPITAL OF AN INDIRECT WHOLLY-OWNED SUBSIDIARY, WE COMPONENTS PTE. LTD.**

JIH had on 8 October 2020 increased the issued and paid-up capital share capital of its wholly-owned subsidiary, We Components Pte. Ltd. by way of allotment and issuance of 18,200,000 ordinary shares in the share capital of We Components Pte. Ltd. for a total aggregate consideration of S\$18,200,000 by way of capitalisation of loan.

None of the Directors or substantial shareholders of the Company have any interest, directly or indirectly, in the allotment and/or capitalisation of the loan, save for their respective shareholdings in the Company.

**D. TRANSFER OF SHARES IN HONFOONG PLASTIC INDUSTRIES PTE. LTD. TO WE TOTAL ENGINEERING SDN BHD**

JIH had on 2 November 2020 transferred 1,400,000 ordinary shares in the share capital of Honfoong Plastic Industries Pte. Ltd. to WE Total Engineering Sdn Bhd for nil consideration.

None of the Directors or substantial shareholders of the Company have any interest, directly or indirectly, in the transfer of shares, save for their respective shareholdings in the Company.
