On 2 September 2015, Medtecs International Corporation Limited (the "Company") entered into a placement agreement with Xia Junwei, pursuant to which the Company will allot and issue to Mr Xia 81,862,275 new ordinary shares of a par value of US\$0.05 each ("Placement Shares") in the share capital of the Company at an issue price of S\$0.07 (equivalent to US\$0.05 at the exchange rate of US\$1.00:S\$1.40) per Placement Share, amounting to a consideration of S\$5,730,359.25 (equivalent to US\$4,093,113.75 at the exchange rate of US\$1.00:S\$1.40). The proposed placement was completed on 15 October 2015. Mr Xia was appointed as director of the Company on the same day.

The above shareholding percentages are calculated based on 549,411,240 issued ordinary shares in the capital of the Company as at 15 October 2015. Any discrepancies in the percentages listed and the totals thereof are due to rounding.
