## NOTICE OF COURT HEARING DATE TO CONVENE THE SCHEME MEETING

## 1. INTRODUCTION

The board of directors of the Company (the "Board") refers to the announcement dated 14 December 2021 (the "Announcement") issued by the Company, in relation to the proposed restructuring of the Company by way of a scheme of arrangement under Section 210 of the Companies Act (Chapter 50 of Singapore) (the "Scheme"), the proposed listing of OFI Group Limited, and the proposed demerger of the Olam Food Ingredients business. As stated in the Announcement, the Scheme involves the imposition of two (2) recently incorporated companies - Olam Group Limited which is incorporated in Singapore and its wholly-owned subsidiary OFI Group Limited which is incorporated in the United Kingdom - between the Company and the Shareholders.

Unless otherwise defined, all capitalised terms used and not defined in this announcement shall have the same meanings given to them in the Announcement.

### 2. NOTICE OF COURT HEARING DATE TO CONVENE THE SCHEME MEETING

- 2.1 As stated in the Announcement, the Scheme is required to be approved by the Shareholders at a scheme meeting (the "Scheme Meeting") to be convened. Leave of the High Court of the Republic of Singapore ("Court") is required to convene the Scheme Meeting. Accordingly, the Company wishes to announce that:
  - (a) an Originating Summons HC/OS 37/2022 (the "Scheme Application") was filed in the Court on 13 January 2022 for leave to convene the Scheme Meeting, in the manner set out in the Scheme Application or such other manner as the Court deems fit; and
  - (b) the Court has directed that the Scheme Application be fixed for hearing at <u>10AM on</u> Tuesday, 25 January 2022.
- 2.2 The Court has additionally directed that any written submissions and bundles of authorities shall be tendered to the Court by 4PM, Wednesday, 19 January 2022.
- 2.3 Any party who wishes to attend the Court hearing on 25 January 2022 should inform the Company's solicitors of such intention by way of email to <a href="mailto:Project.Manna@wongpartnership.com">Project.Manna@wongpartnership.com</a> by 5PM on Tuesday, 18 January 2022.
