ISSUE AND ALLOTMENT OF SHARES PURSUANT TO EXERCISE OF WARRANTS

The Board of Directors of mDR Limited (the “**Company**”) wishes to announce that the issued share capital of the Company has increased from 9,282,653,582 ordinary shares to 9,790,020,246 ordinary shares by way of allotment and issuance of 507,366,664 new ordinary shares pursuant to the exercise of 507,366,664 Warrants (W140925) at the exercise price of S\$0.005 for each new ordinary share on 2 May 2014. These new ordinary shares rank pari passu in all respects with the existing issued ordinary shares in the capital of the Company, and are expected to be listed and quoted on the Singapore Exchange Securities Trading Limited with effect from 6 May 2014.
