## REPLY TO SGX QUERY ON THE THIRD QUARTER RESULTS FOR PERIOD ENDED 31 MARCH 2018 ('Results Announcement')

In response to queries by the SGX in its notification on 31 May 2018, the Board of Directors of the Company would like to provide the following explanations in relation to the Results Announcement:-

## SGX's Query:

Please provide a financial performance review for 3Q2018 against 3Q2017 as well as a breakdown of the material items on the following:-
a. Other operating income
b. Administrative expenses

## Company's response:

## Other operating income

Other operating income decreased by approximately $\mathbf{S} \$ 2.6$ million from $\mathbf{S} \$ 3.1$ million in Q3 FY2017 to S $\$ 0.5$ million in Q3 FY2018. This was mainly due to a decrease in GST tax refund of approximately $\mathrm{S} \$ 1.3$ million, insurance claims of approximately $\mathrm{S} \$ 0.7$ million, and proceeds of approximately S\$0.3 million from scrapped materials in Q3 FY2018.

## Administrative expenses

Administrative expenses increased by approximately $\mathbf{S} \$ 1.3$ million from $\mathbf{S} \$ 5.9$ million in Q3 FY2017 to S\$7.2 million in Q3 FY2018. This was mainly due to an increase in salaries and bonuses. The increase in the line item "salaries and bonuses" was the result of a higher provision for bonus incentives of approximately S $\$ 0.8$ million. In addition, the salary cost has also increased by approximately $\$ \$ 0.5$ million. This was mainly due to the business expansion and increased activities in Singapore, Vietnam and India.
