### CHANGE OF FINANCIAL YEAR END

#### INTRODUCTION

The Board of Directors (the "**Board**") of China Minzhong Food Corporation Limited (the "**Company**" and together with its subsidiaries, the "**Group**") refers to the Company's announcement dated 15 September 2016 in relation to a proposed change to its financial year end, and 7 October 2016 in relation to the results of the extraordinary general meeting (the "**EGM**") held on the same date.

All capitalised terms used in this announcement which are not defined herein shall unless the context otherwise requires have the same meanings ascribed to them in the Company's circular dated 15 September 2016.

## CHANGE OF FINANCIAL YEAR END

Following the approval of the adoption of a new constitution at the EGM, the Board wishes to announce the change of the Company's financial year end from 30 June to 31 December.

In this connection, the Company is proposing to hold its next annual general meeting ("**AGM**") on or before 30 April 2017, and to lay the financial statements for the 18-month period from 1 July 2015 to 31 December 2016. This would mean that the interval between the last AGM, which was held on 30 October 2015 would be more than 15 months, and would result in no AGM being held during the calendar year of 2016.

# APPROVAL FROM THE ACCOUNTING AND CORPORATE REGULATORY AUTHORITY OF SINGAPORE ("ACRA")

The Company has been granted by ACRA an extension of time under Section 175(2) of the Companies Act ("**Act**"), to hold its next AGM on or before 30 April 2017 and to lay the financial statements which are made up to 31 December 2016 at the said AGM.
