- (iii) by personal delivery to the Company's Bermuda Principal Share Registrar c/o RBC Corporate Services Hong Kong Limited of 51/F., Central Plaza, 18 Harbour Road, Wanchai, Hong Kong SAR.

You may at any time by reasonable notice in writing or by email to the Company's Bermuda Principal Share Registrar c/o RBC Corporate Services Hong Kong Limited at (cosec\_genting@rbc.com) change your choice of language or means of receipt of the Company's future Corporate Communications<sup>(Note)</sup>. For this purpose, you may simply complete **Part B** of the Change Request Form and return it by one of the abovementioned methods to the Company's Bermuda Principal Share Registrar c/o RBC Corporate Services Hong Kong Limited. Shareholders are encouraged to select the option of Website Version, which will help preserve the environment and save printing and mailing costs for the Company.
