**COMPANY ANNOUNCEMENT**

**UTILISATION OF PROCEEDS FROM ISSUE OF FOURTH SUB-TRANCHE OF THE TRANCHE 1 RCBs**

*Unless otherwise defined herein or the context otherwise requires, all capitalised terms shall bear the same meanings as ascribed to them in the Company's circular to shareholders dated 21 August 2015 (the "**Circular**").*

LionGold Corp Ltd (the "**Company**") refers to the Circular and its announcements dated 20 June 2015, 12 August 2015, 21 August 2015, 14 September 2015 and 17 September 2015 in relation to the issue of 2.5% redeemable convertible bonds due 2018 in the aggregate principal amount of up to S\$100,000,000 (the "**RCB Issue**"). The Company wishes to provide an update on the utilisation of the net proceeds of approximately S\$950,000 (the "**fourth sub-tranche of Tranche 1 Net Proceeds**") arising from the issue of the fourth sub-tranche of the Tranche 1 RCBs to the Subscriber on 8 March 2016.

The Company has utilised the fourth sub-tranche of Tranche 1 Net Proceeds as follows:
