APPOINTMENT OF LIQUIDATORS FOR INDIRECT WHOLLY-OWNED SUBSIDIARY

Frasers Centrepoint Asset Management Ltd., in its capacity as manager of Frasers Centrepoint Trust (“**FCT**” and as manager of FCT, the “**Manager**”), wishes to announce that Mr Aaron Loh Cheng Lee and Ms Ee Meng Yen Angela, care of EY Corporate Advisors Pte. Ltd. of One Raffles Quay, North Tower, Level 18, Singapore 048583, have been appointed as joint and several liquidators of ARMF (Singapore) Private Limited, an indirect wholly-owned subsidiary of FCT incorporated in Singapore (the “**Singapore Subsidiary**”).

The Singapore Subsidiary is placed into members’ voluntary liquidation as it is no longer active in carrying out its business activity.

The liquidation of the Singapore Subsidiary is not expected to have any material impact on the net tangible assets or distributions per unit of FCT and its subsidiaries for the financial year ending 30 September 2021.
