Unless otherwise expressed or defined herein, all capitalised terms used in this announcement shall have the same meanings as ascribed to them in the Said Announcements (or any of them).

The Company wishes to announce that Fortis has, on 16 September 2026, filed a Special Leave Petition (“**SLP**”) before the Supreme Court of India against the Order dated 31 August 2026 passed by the Delhi High Court in the Execution Proceedings.
