In June 2005, he was appointed as Executive Director of Antah Holdings Berhad (Antah) to spearhead its corporate restructuring and reorganization exercise pursuant to Section 176 of the Companies Act, 1965.

He was part of the team that was entrusted with the overall responsibility of undertaking the many facets of Antah Group's group-wide corporate turn-around and corporate restructuring plans and initiatives.

The task also involved addressing and rectifying the various corporate governance issues faced by Antah that resulted in the suspension of the trading of its shares on Bursa Malaysia. The shares of Antah were re-quoted in June 2006, after a 16-month suspension.

As Executive Director, he undertook a comprehensive legal review of the overall legal position with regards to Antah's investment portfolios, re-assessing legal disputes with various parties, addressing human resource issues and disputes, etc. All these issues had to be managed and resolved within the ambit and scope of Antah's legal constraints and restructuring scheme.
