PAYMENT OF 50% OF MANAGER'S MANAGEMENT FEES BY WAY OF ISSUE OF UNITS IN MAPLETREE COMMERCIAL TRUST

6 May 2020 – Mapletree Commercial Trust Management Ltd., as manager (the “Manager”) of Mapletree Commercial Trust (“MCT”), wishes to announce that 5,242,229 new units in MCT (“Units”) have been issued to the Manager on 6 May 2020 at S\$1.7686 per Unit.

These Units have been issued as payment of (i) 50% of the base fee component of the management fee payable to the Manager for the period from 1 January 2020 to 31 March 2020 (both dates inclusive), and (ii) 50% of the performance fee of the management fee payable for the financial year ended 31 March 2020 in relation to VivoCity, Mapletree Business City I, PSA Building, Mapletree Anson and Bank of America Merrill Lynch HarbourFront. The management fee in relation to Mapletree Business City II is paid entirely in cash.

The issue price is based on the 10-day volume weighted average for the Units up to 31 March 2020.

Following this issuance, the Manager now holds 93,205,401 Units and the total number of Units in issue is 3,312,752,784.
