AMENDMENT AND RESTATEMENT OF FACILITY AGREEMENT - GRANT OF NEW S\$60,000,000 REVOLVING CREDIT FACILITY

Ascendas Hospitality Fund Management Pte. Ltd. as manager of Ascendas Hospitality Real Estate Investment Trust (“**A-HREIT**”) (the “**REIT Manager**”) and Ascendas Hospitality Trust Management Pte. Ltd. as trustee-manager of Ascendas Hospitality Business Trust (“**A-HBT**”) (the “**Trustee-Manager**” and collectively, the “**Managers**”) are pleased to announce that the Trustee-Manager has entered into an amendment and restatement agreement (the “**Amendment and Restatement Agreement**”) relating to the S\$85,000,000 term and revolving facilities agreement dated 18 July 2012 (the “**Original Facility Agreement**” and, as amended and restated by the Amendment and Restatement Agreement, the “**Facility Agreement**”) to reflect certain amendments to, *inter alia*, provide for the grant of a new S\$60,000,000 three-year revolving credit facility (the “**Revolving Credit Facility**” and, together with the other facilities granted pursuant to the Facility Agreement, the “**Facilities**”).

The Revolving Credit Facility will be used to refinance the existing borrowings under the Facility Agreement and to finance the general corporate funding purposes of A-HBT and certain of its subsidiaries.

Rule 704 (31) Disclosure

Pursuant to Rule 704(31) of the Listing Manual of the Singapore Exchange Securities Trading Limited (the “**SGX-ST**”), the Managers wish to inform that the Facilities contain restrictions in relation to any change of the Trustee-Manager as well as any change in control of the Trustee-Manager.

Under the terms and conditions of the Facility Agreement, if:

- (i) the Trustee-Manager ceases at any time to be the trustee-manager of A-HBT and the replacement or substitute trustee-manager is not appointed in accordance with the terms of the deed of trust constituting A-HBT with the prior written consent of the lenders;

The issue managers for the initial public offering and listing of Ascendas Hospitality Trust were DBS Bank Ltd., Nomura Singapore Limited, Standard Chartered Securities (Singapore) Pte. Limited, and The Hongkong and Shanghai Banking Corporation Limited, Singapore Branch (collectively, the “**Issue Managers**”). The Issue Managers assume no responsibility for the contents of this announcement.

- (ii) the Trustee-Manager ceases at any time to be a wholly-owned (directly or indirectly) subsidiary of Ascendas Investment Pte Ltd; or
- (iii) on and from 27 July 2012 (being the date on which Ascendas Hospitality Trust (“**A-HTRUST**”) is admitted to the Official List of the SGX-ST), Ascendas Land International Pte Ltd ceases at any time to hold, directly or indirectly, at least 10.0% of the stapled units in A-HTRUST,

(collectively, the “**A-HBT Events**”), it is an event of default.

As at the date of this announcement, none of the A-HBT Events have occurred. In the event that any A-HBT Event occurs, it may cause a default in the relevant facilities and may also trigger cross default of the other facilities of A-HTRUST. As at the date of this announcement, the aggregate amount of facilities that may be affected is approximately S\$264.3 million⁽¹⁾⁽²⁾ (excluding interest and fees). Ascendas Investment Pte Ltd and Ascendas Land International Pte Ltd also have not entered into any share pledging arrangement or, as the case may be, unit pledging arrangement, in relation to their respective current shareholding in the Trustee-Manager or, as the case may be, current unitholding in A-HTRUST.
