#### The Ordinary Resolution 2 proposed in item 2 above is to seek approval for the payment of up to \$\$280,000 as directors' fees on a current year basis, that is for the financial year ending 31 December 2016. In the event that the amount proposed is insufficient, approval will be sought at next year's annual general meeting for payments to meet the shortfall.

The Ordinary Resolution 9 proposed in item 5 above, if passed, will empower the Directors of the Company to issue shares up to 50% of the Company's issued share capital, with an aggregate sub-limit of 20% of the Company's share capital for any issue of shares not made on a pro-rata basis to shareholders of the Company.

A member of the Company entitled to attend and vote at the AGM may appoint not more than two proxies to attend and vote in his/her instead. A proxy need not be a shareholder of the Company. Where a member appoints more than (i) one proxy, he/she shall specify the proportion of his/her shareholdings to be represented by each proxy.
