Following the disposal of 19,330,000 shares and 5,799,000 shares by BSL Holdings Inc. to Law Boon Seng and Lee Yuet Chin respectively, BSL Holdings Inc. ceased to be a substantial shareholder in Versalink Holdings Limited. Accordingly, Lee Yuet Chin ceased to have a deemed interests in the Company.
