Frasers Property Limited ("FPL") holds a 100% interest (directly or indirectly) in each of FCOAM, FPCTH and FCPMC. Accordingly, FPL has a deemed interest in the aggregate of 293,796,759 FLT Units collectively held by FCOAM, FPCTH and FCPMC by virtue of Section 4 of the Securities and Futures Act, Chapter 289 of Singapore ("SFA").

Maxtop, together with Risen Mark Enterprise Ltd. and Golden Capital (Singapore) Limited, collectively hold more than 20% of the shareholdings of Thai Beverage Public Company Limited ("ThaiBev"). ThaiBev holds a 100% direct interest in International Beverage Holdings Limited ("IBHL"). IBHL holds a 100% direct interest in International Beverage Holdings Limited ("IBHL"). IBHL holds a 100% direct interest in International Beverage Holdings Company Limited ("A the sharehold set interest in International Beverage Holdings Limited ("IBHL").
