# CHANGE OF NAME OF CACHE LOGISTICS TRUST TO ARA LOGOS LOGISTICS TRUST AND CHANGE OF NAME OF THE MANAGER AND THE PROPERTY MANAGER

# 1. Change of name to ARA LOGOS Logistics Trust

The Board of Directors of ARA LOGOS Logistics Trust Management Limited (formerly known as ARA Trust Management (Cache) Limited), as manager of ARA LOGOS Logistics Trust (the "REIT", and the manager of the REIT, the "Manager"), wishes to announce that, with the approval of HSBC Institutional Trust Services (Singapore) Limited, in its capacity as trustee of the REIT (the "Trustee"), the name of the REIT has changed from "Cache Logistics Trust" to "ARA LOGOS Logistics Trust" with effect from today.

In connection with the above, the Manager wishes to announce that a sixth supplemental deed has been entered into on 28 April 2020 between the Manager and the Trustee, to amend the deed of trust dated 11 February 2010 constituting the REIT, as amended, restated or supplemented from time to time.

The sixth supplemental deed will be available for inspection at the registered office of the Manager for so long as the REIT is in existence.

#### 2. Change of Trading Name

The trading name of the REIT will change from "Cache Log Trust" to "ARA LOGOS Log Tr" with effect from 9.00 a.m., 30 April 2020. For the avoidance of doubt, the trading code of the REIT, K2LU, will remain the same.

In addition, the trading name of the \$\$100,000,000 5.5% Subordinated Perpetual Securities issued by the REIT will also change from "CACHE \$\$100M5.5% PERP" to "ARA LOGOS 5.5% PS".

# 3. New Website

# 4. Change of name of the Manager

The name of the Manager has changed from "ARA Trust Management (Cache) Limited" to "ARA LOGOS Logistics Trust Management Limited" with effect from today.

The name of the property manager of the REIT has changed from "Cache Property Management Pte. Ltd." to "ARA LOGOS Property Management Pte. Ltd." with effect from today.
