On 23 September 2014, Allcare Investment Holdings Pte Ltd ("Allcare") entered into a contract with SHC Capital Holdings Pte Ltd ("SHCPL") to transfer 3,627,000 shares in the capital of SHC Capital Asia Limited ("SHC Asia") to SHCPL ("the Transaction"). As a result, SHCPL has a direct interest in 246,012,317 shares in the capital of SHC Asia and a deemed interest in 3,627,000 shares in the capital of SHC Asia.

Mr. Teo Soo Chew has a total deemed interest in 249,639,317 shares in the capital of SHC Asia representing 81.59% the total number of voting shares in SHC Asia, comprising his deemed interest in: (i) 246,012,317 shares in the capital of SHC Asia held by SHCPL, a wholly-owned subsidiary of See Hoy Chan Holdings Pte Ltd ("SHCH"), which is in turn a wholly-owned subsidiary of See Hoy Chan Sdn. Berhad ("SHCSB"), by virtue of his interest in SHCSB; and (ii) 3,627,000 shares in the capital of SHC Asia held by Allcare, by virtue of his interest in SHCSB, as SHCSB has a 74.23% interest in Allcare, and SHCH, which is a wholly-owned subsidiary of SHCSB, has a 25.77% interest in Allcare.
