As announced on 8 August 2023 by ARA Trust Management (USH) Pte. Ltd., as manager of ARA US Hospitality Property Trust ("**ARA H-REIT**"), and ARA Business Trust Management (USH) Pte. Ltd., as trustee-manager of ARA US Hospitality Management Trust ("**ARA H-BT**") (collectively known as the "**Managers**"), the declared distribution of 1.501 U.S. cents per stapled security in ARA US Hospitality Trust ("**Stapled Security**" and holders of Stapled Securities, "**Stapled Securityholders**") for the period from 1 January 2023 to 30 June 2023 will be paid on Wednesday, 27 September 2023.

Stapled Securityholders who have opted to receive their distributions in U.S. dollars will receive 1.501 U.S. cents per Stapled Security.
