**RESPONSES TO SUBSTANTIAL AND RELEVANT QUESTIONS RECEIVED FROM
SHAREHOLDERS FOR THE 26 JUNE 2020 ANNUAL GENERAL MEETING**

The Board of Directors of Koyo International Limited (“**Company**”) and together with its subsidiaries, collectively known as the “**Group**”) refers to the publishing of its annual general meeting related documents on the SGXNET on 15 April 2020 and 11 June 2020. As at 2pm on 22 June 2020, the Company has received the following questions from shareholders and the Company wishes to provide its responses:

Questions Received from Shareholders:

Q1. How is the COVID-19 situation affecting the Company’s operations?

- A. Although the provision of services in relation to facilities management by the Company is being classified as part of “essential services”, the circuit breaker measures implemented since 7 April 2020 to date have resulted the in Group’s operations being scaled down, including its projects being put on hold. Stringent health and safety distancing measures imposed by the relevant authorities had also affected the construction sector, which has also reduced the Group’s productivity.

Since the onset of the COVID-19 pandemic in Singapore, the Group has also implemented preventive measures including but not limited to regular temperature taking, safe distancing measures, surgical mask are made readily available to employees and employees are required to work from home insofar as practicable.

The Group has resumed its operations after lifting of the circuit breaker measures but is still subject to compliance with stringent measures.

Q2. Do you have any dormitory workers impacted by the coronavirus?

- A. One of the Group’s dormitory worker had been infected with the COVID-19 disease. The related dormitory had been isolated at the time and the worker had since been declared free of the virus and is in good health. The Group continues its proactive efforts by working closely with the government agencies and continues to keep in close contact with all employees to monitor their health, safety and well-being.
