The lease at Tampines Street will commence on 15 September 2024 and expire on 14 September 2027, and the lease terms include a one-and-a- half-month rent-free period from 1 August 2024 for renovations.

The Group expects to obtain the necessary approvals and licences and relocate its Binjai Clinic and Tampines Clinic to the new premises at Mandai Road and Tampines Street respectively by 31 October 2024.

The Company believes that extending the current leases to 31 October 2024 will ensure the continuity of the Group's business with minimal disruption, whilst allowing the Group to have adequate time to prepare for the relocations. The Company expects that the relocation of its veterinary clinics will enhance the Group's service offerings and improve its operational efficiency.
