## YONGNAM SECURES TWO CONTRACTS WORTH S\$22.8 MILLION

- Specialist civil engineering contract in Hong Kong
- Mechanical engineering contract for the Trisonic Wind Tunnel in Singapore

*Singapore, December 15, 2014* – Yongnam Engineering (HK) Limited., a whollyowned subsidiary of Yongnam Holdings Limited ("Yongnam" or the "Group"), has secured a specialist civil engineering contract in Hong Kong for the Central-Wan Chai Bypass Tunnel development. Another wholly-owned subsidiary, Yongnam Engineering & Construction Pte. Ltd., has secured a mechanical engineering contract for Addition & Alteration ("A&A") works for the Trisonic Wind Tunnel in Singapore. The combined value for the two contracts is S\$22.8 million.

The civil engineering contract in Hong Kong is for Excavation Lateral Support (ELS) works at Hong Kong's Wan Chai West, for the Central – Wan Chai Bypass Tunnel (Main Tunnel and Middle Ventilation Building). Work on this project is expected to commence in January 2015, with completion slated for December 2016.

The mechanical engineering contract is for the replacement of air storage tanks at the Singapore Wind Tunnel Facility (SWIFT) located at the National University of Singapore. Work on this project is expected to commence in early 2015 and is expected to be completed within the calendar year. Yongnam's scope of work for this project includes the dismantling and disposal of existing air tanks, and the supply, installation, maintenance, testing and commissioning of new air tanks. This also marks Yongnam's third contract for the Trisonic Wind Tunnel, following earlier contracts for refurbishment and reinstallation works in 2002; and maintenance works between 2006 and 2007. "This is a period of exciting developments for Yongnam, supported by a healthy order momentum as we continue to expand our participation in infrastructural developments in Singapore and overseas." Mr Seow added.

These contracts are not expected to have a favourable impact on the Group's financial performance for the year ending December 31, 2014.
