MONTHLY UPDATE PURSUANT TO CATALIST RULE 704(22)

Pursuant to Catalist Rule 704(22), Blackgold Natural Resources Limited (the “**Company**”) wishes to provide an update on recent developments in relation to the Judicial Management of the Company.

The Company refers to its announcement dated 29 May 2026 for the month of May 2026 as well as its announcement dated 19 June 2026 in respect of (a) the Company’s entry into an Investment Funding Agreement in relation to the proposed investment by PT Rajawali Artha Global (“**RAG**”) into the Company, and consequently (b) the extension of the Judicial Management of Company. For the reasons explained in the latter announcement, the Company filed an application in the General Division of the High Court of the Republic of Singapore, namely, HC/OA 645/2026 (“OA 645”) for an order that the term of the office of the Judicial Manager and the term of the Judicial Management of the Company be extended for a further period of eight (8) months with effect from 24 July 2026 pursuant to Section 111(3)(a) of the IRDA, until 23 March 2027. OA 645 is now fixed for hearing on 22 July 2026 at 2.30pm before the Honourable Justice Audrey Lim. The Court has also directed that (a) the Judicial Manager is to file a Supplementary Affidavit on 15 July 2026, 4pm to exhibit the latest notices to creditors regarding the hearing date and any views of creditors; (b) that written submissions and the bundle of authorities be filed by 15 July 2026 4pm, and (c) that hard copies of affidavits and written submissions are to be submitted by 15 July 2026, 4pm. Thus, any creditor who wishes to attend the hearing may contact the Judicial Manager for the details of the hearing at his office telephone number at 6222 7496 or by way of email at farooq.mann@mann.com.sg.

The Company will make further announcements to update shareholders on material developments as and when appropriate, in compliance with the requirements of the Catalist Rules.

Shareholders and potential investors are therefore advised to read this announcement and any further announcements by the Company carefully. Shareholders and potential investors should consult their stockbrokers, solicitors or other professional advisors if they have any doubts about the action they should take.
