On 21 November 2018, AMP Capital Investors Limited, AIMS Financial Service Group Pty Ltd, AMP Capital Finance Limited ("AMPCF"), AIMS Financial and Great World entered into an implementation agreement dated 21 November 2018 ("Implementation Agreement") in relation to the sale of, inter alia, 500,000 ordinary shares in the capital of the REIT Manager ("Sale Shares") by AMP Capital Investors International Holdings Limited to AIMS Financial, representing 50% of the issued and paid-up share capital of the REIT Manager.

The Implementation Agreement was subsequently amended and AIMS Financial nominated its wholly-owned subsidiary, Great World, to purchase the Sale Shares. Completion of the sale of the Sale Shares occurred on 28 March 2019, following which Great World holds a direct interest in 50% of the issued and paid-up share capital of the REIT Manager. As AIMS Financial holds 100% of Great World, it is deemed interested in the Sale Shares, in addition to the shares which it currently holds in the REIT Manager.


