Recent deals that embody Charisma's commitment to this strategy include (i) the announcement in the acquisition of 50% equity interest in Grenzone Pte Ltd, a solar photovoltaic engineering, procurement and construction company in December 2015; (ii) a January 2016 announcement of a notice of award granted to its joint venture to develop a 140 megawatt ("MW") solar photovoltaic power plant in Rajasthan, India; and (iii) in May 2016, Charisma announced the acquisition of an 80% equity interest in an entity to develop a 20MW solar photovoltaic power plant in Hubei Province, China. The above projects are in addition to the Group's existing portfolio of renewable energy assets in South Asia.

As a Singapore listed company, Charisma is equipped with both access to capital required to move quickly on new opportunities, and the experience and governance to deliver sustainable profits for investors, shareholders and business partners alike.

With the launch of a fresh logo, Charisma will over the coming months, be building on this new commercial strategy and is pleased to announce today their focus, and

long term commitment, to owning, developing and operating renewable energy assets across Asia's emerging economies.
