The Group's increased stake deepens collaborative efforts between the two companies following Trek's initial investment in Terrenus Energy back in 2019. There are significant synergies to be unlocked, leveraging on Trek's extensive R&D and IoT capabilities, both parties aim to develop and apply smart renewable power systems to capture growth in the burgeoning renewable energy market where demand for such modern-day solutions are surging.

Since the onset of the pandemic, there has been a variety of issues which has led to a downturn in the global economy. While the pandemic situation appears to be stabilizing, the acute oil and gas supply
