United Overseas Bank Limited (the "Company"), wishes to announce that it intends to issue GBP750,000,000 Floating Rate Covered Bonds due 2027 (the "Covered Bonds"). The Covered Bonds will be issued as the twelfth series under the US\$15 billion Global Covered Bond Programme (the "Covered Bond Programme"). United Overseas Bank Limited, BNP Paribas, UBS AG London Branch, Societe Generale and HSBC Bank PLC have been appointed as joint lead managers for the Covered Bonds.

The Company is pleased to announce that it has priced the offering of the Covered Bonds and the principal terms of the Covered Bonds are as follows:

Issue Size: GBP750,000,000

Instrument: GBP Floating Rate Covered Bonds

Issue Price: 100% of the principal amount of the Covered Bonds

Coupon: Compounded Daily SONIA + 0.53% per annum payable quarterly

in arrear





Currency: Sterling

Guarantee: The Covered Bonds will be guaranteed as to payments of interest

and principal by Glacier Eighty Pte. Ltd. (the "<u>CBG</u>"). The guarantee is secured by a portfolio of loans purchased by the

CBG from the Company and other assets of the CBG

Ratings: The Covered Bonds are expected to be rated Aaa by Moody's

Investors Service and AAA by Standard & Poor's Rating Services

Maturity Date: It is intended that the Covered Bonds will mature on the interest

payment date falling on or nearest to 13 September 2027
