The Listed Issuer will attach both forms to the prescribed SGXNet announcement template for dissemination as required under section 137G(1), 137R(1) or 137ZC(1) of the SFA, as the case may be. While Form C will be attached to the announcement template, it will not be disseminated to the public and is made available only to the Monetary Authority of Singapore (the "Authority").

A single form may be used by a Director/CEO for more than one transaction resulting in notifiable obligations which occur within the same notifiable period (i.e. within two business days of/of becoming aware of, the earliest transaction). There must be no netting-off of two or more notifiable transactions even if they occur within the same day.

- The change in Mr Yuen Kuan Moon ("Mr Yuen")'s deemed interest is a consequence of the vesting of the performance shares granted to him in 2020, 2021 and 2022 (see details in paragraphs 2, 3 and 4 below). The deemed interest of 4,857,526 shares immediately after the transaction referred to in Table 1 comprises:
 - 6,360 ordinary shares held by Ms Tan Chay Ngee, spouse of Mr Yuen; and
 - an aggregate of up to 4,851,166 ordinary shares in Singapore Telecommunications Limited ("Singtel") awarded to Mr Yuen in 2021 and 2022 (see paragraphs 3 and 4 below) pursuant to the Singtel Performance Share Plan 2012 ("PSP 2012"), subject to certain performance conditions being met and other terms and conditions. Depending on the extent of the satisfaction of the relevant performance criteria, up to an aggregate of 6,945,407 shares may be released pursuant to the conditional awards granted.
- Performance shares granted to Mr Yuen in 2020:
 - In respect of the 148,216 shares comprised in the Restricted Share Award ("RSA") granted to Mr Yuen in 2020 under the PSP 2012, 100% or 148,216 of such shares have vested in accordance with the Rules of the PSP 2012. 50% or 74,108 of such shares were released to Mr Yuen on 1 June 2022, and 50% or 74,108 of such shares were released to Mr Yuen on 1 June 2023.
 - In respect of the 526,429 shares comprised in the Performance Share Award granted to Mr Yuen in 2020 under the PSP 2012, 19% or 100,022 of such shares have vested and were released to Mr Yuen in accordance with the Rules of the PSP 2012 on 1 June 2023. The balance of 81% or 426,407 of unvested shares will lapse on 1 June 2023.
- Performance shares granted to Mr Yuen in 2021:
 - In respect of the 170,659 shares comprised in the RSA granted to Mr Yuen in 2021 under the PSP 2012, two-thirds or 113,773 of such shares have vested in accordance with the Rules of the PSP 2012. One-third or 56,887 of such shares were released to Mr Yuen on 1 June 2022, and one-third or 56,886 of such shares were released to Mr Yuen on 1 June 2023. The balance one-third or 56,886 of such shares will vest to Mr Yuen, in accordance with the Rules of the PSP 2012, on or after 1 June 2024.
 - In respect of the One-off Long-Term Incentive Award granted to Mr Yuen in 2021, depending on the extent of satisfaction of the relevant performance criteria, up to an aggregate of 6,282,723 shares may be released.
- Performance shares granted to Mr Yuen in 2022:
 - In respect of the 908,698 shares comprised in the RSA granted to Mr Yuen in 2022 under the PSP 2012, one-third or 302,900 of such shares have vested and were released to Mr Yuen in accordance with the Rules of the PSP 2012,

on 1 June 2023. The balance two-thirds or 605,798 of such shares will vest to Mr Yuen in two equal tranches, in accordance with the rules of the PSP 2012, on or after 1 June 2024 and 1 June 2025 respectively.
