ELYSIUM SECURES FREEHOLD LAND OVER THE LLOYD'S COPPER DEPOSIT

Highlights

- Elysium Resources has acquired the freehold land covering the Lloyd's Copper Resource at the Burraga Cu-Au Project in NSW.
- Acquisition of freehold title is of strategic importance to Elysium Allows quicker access for ongoing exploration and development programs.
- Further strengthens the Company's position in the world class East Lachlan Fold Belt.
- Drilling of priority targets at the Burraga Project due to commence in the near future

Elysium Resources Limited ("Elysium" or the "Company") (ASX: EYM) is pleased to announce that it has acquired the freehold land containing the Lloyd's Copper Deposit within the Company's Burraga Copper-Gold Project in New South Wales (Figure 1).

Elysium will acquire Lot 12 DP 241638, which covers a total area 80.41 of hectares in and around the Lloyd's resource area.

The acquisition of freehold title at Lloyds is of strategic importance to the Company. It removes the requirement to seek landholder access approvals to pursue its activities at the project area and will enable more flexibility for Elysium's ongoing exploration programs and possible mining scenarios.

The move to secure freehold title over the Lloyds Deposit further strengthens Elysium's position at Burraga and comes after the Company recently expanded its project area at Burraga, via a new Exploration Licence (ELA 5454). The new ELA covers an area of 83.52km² and increases the Company's contiguous Burraga Project land holding from 138km² to 221.5km² (ASX announcement 27th of Feb, 2017).

Elysium's drilling planned program at the Burraga Project is due to commence in the near future and the Company will provide further information on the timing of the commencement of drilling and details of program shortly.
