**UPDATE ON THE PROPOSED ACQUISITION OF
ZHUANGHE CITY AOXIN DAWEI DENTAL CO., LTD.**

1. INTRODUCTION

- 1.1 The Board of Directors (the "**Board**" or the "**Directors**") of Aoxin Q & M Dental Group Limited (the "**Company**", and together with its subsidiaries, the "**Group**") refers to its announcements dated 15 May 2017 and 18 September 2017 (the "**Earlier Announcements**") in relation to the proposed acquisition of Zhuanghe City Aoxin Dawei Dental Co., Ltd. ("**Aoxin Dawei**") by Shenyang Xinao Hospital Management Co., Ltd., ("**Shenyang Xinao**") (the "**Proposed Acquisition**").

Unless otherwise defined in this announcement, all capitalised terms used in this announcement shall have the same meanings as set out in the Earlier Announcements.
