Morze International Limited ("Morze") is indirectly held by Highvern Trustees Limited, as trustee of the Capital Two Trust, through bare trustees, Magnus Nominees Limited and Fidelis Nominees Limited. The Capital Two Trust is a reserved power discretionary trust.

The beneficiaries of the Capital Two Trust are Rachel Anastasia Kolonas, her issue and remoter issue and Tati Santosa. Pursuant to Section 4 of the Securities and Futures Act ("SFA"), the beneficiaries of the Capital Two Trust are deemed to have an interest in the shares in the Company ("Shares") held by Morze.

Under the terms of the Capital Two Trust, Rachel Anastasia Kolonas is entitled, as an investment power holder, to direct the trustee of the Capital Two Trust to procure to the best of its ability that the directors of Morze act in accordance with her instructions in relation to the investments of the Capital Two Trust. Accordingly, she can control the exercise of the rights of the Shares held under the Capital Two Trust and is deemed to have an interest in the Shares held by Morze under Section 4 of the SFA.

Morze had a direct interest in 282,527,085 Shares prior to the Rights Issue, and was allotted a further 28,252,708 Shares on 7 February 2020 following acceptance of 28,252,708 Rights Shares under the Rights Issue. Accordingly, Morze has a direct interest in 310,779,793 Shares following the Rights Issue.
