APPROVAL OF APPLICATION FOR FURTHER EXTENSION OF TIME TO HOLD THE ANNUAL GENERAL MEETING FOR THE FINANCIAL PERIOD ENDED 31 DECEMBER 2017

*Unless otherwise specified, all capitalised terms shall have the same meaning ascribed to the announcement dated 21 March 2018, 4 April 2018, 3 May 2018 and 7 May 2018 in relation to the application for an extension of time to hold the Annual General Meeting for the financial period ended 31 December 2017 ("**Announcements**").*

The Board of Directors ("**Board**") of Asiatravel.com Holdings Ltd ("**Company**") and together with its subsidiaries, "**Group**") refers to the Announcements and wishes to announce that the SGX-ST has on 9 May 2018 informed the Company that the SGX-ST has no objection to the Company's Further Extension Application to hold the AGM for FP2017 by 25 June 2018 pursuant to Rule 707(1) of the Catalist Rules, subject to:

- (i) the Company making an immediate announcement of the extension granted, disclosing the reasons for seeking the extension and conditions imposed; and
- (ii) the Company convening the AGM by 25 June 2018;
- (iii) the Company issuing its annual report to shareholders and the Exchange at least 14 days before the date of its AGM; and
- (iv) the Company obtaining approval from the ACRA for the same extension.

The Company will make further announcements as and when there are further updates on the Further Extension Application. As announced on 3 May 2018, the Further Extension Application is necessary as the annual report of the Company for FP2017 will not be ready in time to allow the Company to issue its annual report to shareholders of the Company at least 14 days prior to 25 May 2018, being the last date for the Company to hold its AGM pursuant to pursuant to the extension granted by the SGX-ST on 3 April 2018.
