NOTES TO THE CONDENSED CONSOLIDATED FINANCIAL STATEMENTS

For the first quarter ended June 30, 2020

1. GENERAL

The Company was incorporated in Bermuda on August 3, 2000 as an exempted company with limited liability under the Companies Act 1981 of Bermuda with its registered office at Victoria Place, 5/F, 31 Victoria Street, Hamilton HM10, Bermuda. Its principal place of business is located at 24/F, Wyler Centre, Phase 2, 200 Tai Lin Pai Road, Kwai Chung, New Territories, Hong Kong. The issued ordinary shares of the Company are listed and traded on the Main Board of Singapore Exchange Securities Trading Limited (the "SGX-ST") and the Main Board of The Stock Exchange of Hong Kong Limited. The condensed consolidated financial statements of the Group are presented in Hong Kong dollars which is also the functional currency of the Company. All values are rounded to the nearest thousand except otherwise indicated.

The principal activity of the Company is investment holding and the Company's subsidiaries are principally engaged in the trading of electronic components.

2. PRINCIPAL ACCOUNTING POLICIES

The condensed consolidated financial statements have been prepared on the historical cost basis, except for certain properties and financial instruments, which are measured at fair values, as appropriate at the end of each reporting period.

Other than the application of new accounting policies, and the changes in accounting policies resulting from the application of new and amendments to International Financial Reporting Standards ("IFRS Standards") issued by the International Accounting Standards Board, which are first effective for the current accounting period, the accounting policies and methods of computation used in the condensed consolidated financial statements for the three months ended June 30, 2020 are the same as those followed in the preparation of the Group's annual financial statements for the year ended March 31, 2020. The application of the amendments to IFRS Standards and the interpretation in the current period has had no material impact on the Group's financial positions and performance for the current and prior periods and/or on the disclosures set out in these condensed consolidated financial statements.

MANAGEMENT DISCUSSION AND ANALYSIS

BUSINESS REVIEW

The Group recorded a profit attributable to owners of the Company of HK\$7.1 million for the three months ended June 30, 2020 ("1Q FY2021") compared to a loss attributable to owners of the Company of HK\$24.6 million for the three months ended June 30, 2019 ("1Q FY2020"). The Group returned to profit in 1Q FY2021 mainly due to higher gross profit as no stock provision was required to be made in 1Q FY2021 while a stock provision of HK\$8.3 million for slow-moving inventories was made in 1Q FY2020; and a decrease in staff cost and travelling expenses due to a reduced average headcount and in light of the coronavirus disease 2019 ("COVID-19") pandemic respectively. Furthermore, there was no significant exchange difference in 1Q FY2021 whereas there was an exchange loss arising from the depreciation of the Renminbi ("RMB") in 1Q FY2020.

Revenue

The Group's sales revenue had decreased by 3.9% from HK\$792.2 million in 1Q FY2020 to HK\$761.3 million in 1Q FY2021.

The whole market felt the impact of the COVID-19 outbreak since the beginning of year 2020 and it continues to affect the industry presently. Consumer spending on traditional electronics product was almost frozen. Lock-down measures implemented by China, parts of Asia, Europe and the United States of America ("US") to curb the spread of the virus led to severe supply chain disruptions across the world and impacted the export business.

The total sales achieved by the Group in 1Q FY2021 fell by 3.9% compared to the corresponding period of last year. The decline was mainly due to a double-digit decrease in sales by consumer-centric segments such as Home Appliance, Telecommunications and Audio and Video, which was partially offset by a double-digit expansion in the Automotive and EMS segments and modest growth of the Industrial, Lighting and Others segments.

The gains in the Industrial, EMS and Others segments were mainly due to the new "work-from-home" norm which benefitted some applications such as on-line education/ meeting, in-home entertainment and cooking. This supported the sales of personal computers, tablets, games, set-top boxes and power related products.

The strong growth of 29.7% in Automotive segment was partially due to the lower base from the same period in 1Q FY2020. This segment also rebounded quickly from pent-up demand following the lock-down in China. The automotive industry in China had resumed production in April 2020 and took advantage of the Chinese Labour Day holiday to boost sales with huge discounts to clear stocks. From May 2020, the industry started to replenish the supply chain. With the support from the policy of the Chinese government, this segment is expected to continue its growth trajectory.

Gross Profit Margin

The Group's gross profit margin increased from 6.9% in 1Q FY2020 to 7.7% in 1Q FY2021 mainly due to no stock provision was required to be made in 1Q FY2021 while a stock provision of HK\$8.3 million for slow-moving inventories was made in 1Q FY2020.

Distribution Costs

Distribution costs decreased by HK\$4.4 million, or 49.3%, from HK\$8.9 million in 1Q FY2020 to HK\$4.5 million in 1Q FY2021. The decrease was mainly due to a decrease in travelling and entertainment expenses for the period under review as a result of the outbreak of the COVID-19 pandemic and the subsequent quarantine measures as well as travel restriction imposed by the governments of various countries/districts.

Administrative Expenses

Administrative expenses decreased by HK\$11.5 million, or 22.4%, from HK\$51.4 million in 1Q FY2020 to HK\$39.9 million in 1Q FY2021. This was mainly due to (i) a substantial decrease in staff costs owing to lower average headcount; (ii) the implementation of cost control measures; and (iii) the reduction and exemption of corporate social insurance premiums in the PRC according to the notice jointly released by the Ministry of Human Resources and Social Security, the Ministry of Finance, and the State Taxation Administration of the PRC in February 2020.

Other Gains and Losses

Other gains of HK\$0.1 million in 1Q FY2021 represented mainly a gain on disposal of fixed assets, whereas other losses of HK\$9.7 million in 1Q FY2020 were incurred due to an exchange loss mainly arising from the depreciation of RMB. There was no significant exchange difference in 1Q FY2021.

Finance Costs

Finance costs decreased by HK\$3.0 million, or 31.7%, from HK\$9.5 million in 1Q FY2020 to HK\$6.5 million in 1Q FY2021. The decrease was mainly due to a reduction in average trust receipt loans and bank borrowings as well as a decrease in weighted average effective interest rate as compared to the same period last year.

LIQUIDITY AND FINANCIAL RESOURCES

Financial Position

As at March 31, 2020, the aggregate amount of trust receipt loans and bank borrowings was HK\$670.9 million as compared to HK\$680.8 million as at June 30, 2020. Trade payables maintained at similar levels, with a slight increase from HK\$305.9 million as at March 31, 2020 to HK\$306.0 million as at June 30, 2020. The overall increase in trust receipt loans and bank borrowings was mainly due to the increase in purchasing activities in 1Q FY2021 as compared to previous quarter (January to March 2020). Trade receivables as at June 30, 2020 increased by HK\$65.7 million as compared to those as at March 31, 2020, due to an increase in sales revenue towards the end of the period under review, and the debtors turnover days increased from 2.5 months to 2.9 months.

Inventories

Inventories slightly increased from HK\$375.1 million as at March 31, 2020 to HK\$384.4 million as at June 30, 2020. The inventory turnover days increased from 1.5 months to 1.7 months.

Cash Flow

As at June 30, 2020, the Group had a working capital of HK\$316.0 million which included a cash balance of HK\$213.8 million, compared to a working capital of HK\$302.0 million which included a cash balance of HK\$264.8 million as at March 31, 2020. The decrease in cash by HK\$51.0 million was primarily attributable to the net effect of cash outflows of HK\$56.5 million in operating activities and a cash inflow of HK\$5.5 million generated from financing activities.

Cash outflow in operating activities was mainly attributable to an increase in trade receivables. The increase in trade receivables was due to the increased sales revenue towards the end of the period under review when compared with the sales revenue towards March 31, 2020.

Cash inflow generated from financing activities was attributable to the overall increases in trust receipt loans and bank borrowings as a result of increasing purchasing activities.

As at June 30, 2020, the Group's trade receivables amounted to HK\$84.7 million (March 31, 2020: HK\$69.9 million), which were transferred to banks by discounting those trade receivables on a full recourse basis. As the Group had not transferred the significant risks and rewards relating to these receivables, it continued to recognise the full carrying amount of the receivables and had recognised the cash received on the transfer as secured borrowings amounting to HK\$74.1 million (March 31, 2020: HK\$63.7 million).

STRATEGY AND PROSPECTS (A commentary at the date of the announcement of the significant trends and competitive conditions of the industry in which the Group operates and any known factors or events that may affect the Group in the next reporting period and the next 12 months)

The Chinese government's decisive response and approach to contain the COVID-19 outbreak, including restricting people movement and massive testing, enabled China to take control of the pandemic quickly and resume business activities from March 2020.

As a result, China avoided a recession and its GDP grew by 3.2% year on year in the second quarter (April to June) of 2020 after the historic contraction of 6.8% year on year in the first quarter (January to March) of 2020.

The Group expects China's economy to continue gaining traction in the second half of the year albeit with increased cautiousness over the virus, which has yet to be completely eradicated. We also expect increased challenges from the ongoing and deteriorating relations between the US and China.

In unprecedented times like now, the Group will continue to be prudent in managing its resources and expenses to ensure that our operations remain sustainable to tide over the uncertain business environment.

DIVIDEND

The Board has resolved not to declare the payment of a dividend for the three months ended June 30, 2020 (1Q FY2020: nil) as the Group intends to retain cash for its business operations.

AUDIT OR REVIEW OF THE FINANCIAL RESULTS
