MERMAID SECURES ADDITIONAL SUBSEA CABLE INSTALLATION AND RELATED DIVING SERVICES CONTRACT

Mermaid Maritime Public Company Limited ("Mermaid") is pleased to announce that its Qatari business unit Mermaid Subsea Services LLC in Qatar ("MSSQ") has been awarded an additional subsea cable installation and related diving services assignment from an existing customer, a global cable manufacturing, installation and commissioning company.

The work scope has an estimated value of USD 10 million and is scheduled for completion within 3 months. Commencement date will be in April 2016. The work will utilize chartered-in DP2 construction barge 'Mubarak Supporter' along with other specialized vessels (if required) plus associated equipments and specialist personnel.

In 2013, Mermaid announced the establishment of a new cable lay division as part of its strategic initiative to expand its service offering to customers in the Middle East. Since founding this division Mermaid has successfully completed several cable lay projects to date.

Mermaid's contract win announcements as published from time to time on SGXNet are not exhaustive as Mermaid continues to be awarded other smaller contracts from time to time in the ordinary course of business which are added to its order book.

<u>Financial Effects</u>

Assuming that the contract had commenced and had been completed within the most recent financial year (the Company's last financial year ended 31 December 2015), the contract would have had a non-material effect on the earnings per share of the Company (on a consolidated basis) and a non-material effect on the net tangible assets per share of the Company (on a consolidated basis) for that financial year.

indirect, in the contract. There are also no new directors proposed to be appointed to the

Company in connection with the contract.
