Harvest Global Dynamic Fund SPC acting on behalf of and for the account of Harvest Environmental Investment Fund SP (the "SPC") holds 214,000,000 ordinary shares in the capital of Zheneng Jinjiang Environment Holding Company Limited ("Shares"). While Harvest Global Capital Investments (Cayman) Limited is the manager of the relevant fund, the investment committee of the fund comprises a representative from the fund manager, and a representative from each of its two investors, one of whom is Kung Chak Ming. Accordingly, Kung Chak Ming has control over the business and affairs of the SPC, including making investment and divestment decisions and voting the securities and interests held by the SPC, including those in Zheneng Jinjiang Environment Holding Company Limited. Pursuant to Section 4 of the SFA, Kung Chak Ming is deemed to have an interest in the Shares held by the SPC.
