Mr Måns Lidgren, the Company's CEO and an associate of a controlling shareholder of Rex International Holding

Limited (the "Company"), was issued and allotted 7,909,600 ordinary shares in the share capital of the Company ("Shares") on 9 May 2018 pursuant to the vesting of the share award which was granted to him on 29 April 2016 under the Rex International Performance Share Plan ("Rex PSP").

The percentage of shares before the transaction is computed based on 1,283,310,851 ordinary shares in the issued and paid up capital of Rex International Holding Limited.

The percentage of shares after the transaction is computed based on 1,291,220,451 ordinary shares in the issued and paid-up capital of Rex International Holding Limited.

Mr Måns Lidgren was granted a contingent award of up to 30,943,600 shares in the share capital of the Company on 28 April 2017 pursuant to the Rex PSP (the "Award"). The vesting and release of the Award and the actual number of Shares to be delivered is subject to the achievement of certain performance benchmarks being met and the satisfactory completion of time-based service condition(s) decided by the committee administering the Rex PSP. If the conditions are satisfied, the Shares will be released to Mr Måns Lidgren in one or more tranches after the end of a one year vesting period which may extend up to a maximum of two years from the date of the grant of the Award.
