ASSOCIATED COMPANY OF SLB, 32RE, ANNOUNCES S\$150M EQUITY JOINT VENTURE WITH WEAVE

Singapore, 24 June 2020 – Subsidiaries of 32 Real Estate Pte. Ltd. ("32RE" and together with its subsidiaries, the "32RE Group"), a newly-established real estate investment management platform and an associated company of SLB Development Ltd. ("SLB" and together with its subsidiaries, the "Group"), announced the entry into a subscription and shareholders agreement with Weave Co-Living ("Weave") to establish a S\$150 million equity joint venture ("JV") to acquire, develop, refurbish and operate co-living and rental accommodation assets in Singapore under Weave or its affiliated brands. Weave will be responsible for day-to-day management of the JV's assets.

Mr Matthew Ong (王荣强), Executive Director and CEO of SLB, said, "We are pleased to extend our focus in our fund management business through this partnership between 32RE and Weave. This ties in well with our intention to deepen our focus on the co-living and accommodation segment. Apart from diversifying our income stream, the fund management business will also provide SLB with access to like-minded partners and reputable, global investors."

Founded in 2017 by Sachin Doshi in Hong Kong, Weave provides high quality, modern, conveniently located, secure and design-led living spaces for global citizens, delivering fantastic value. In November 2018, global private equity firm Warburg Pincus invested US\$181 million of growth capital in Weave to expand its hassle-free city living offering across major gateway cities throughout Asia Pacific, with an option to increase its investment up to US\$413.5 million.



Other Details of the Partnership

Weave will own 80% of the JV, while the remaining 20% will be owned by a fund managed by the 32RE Group. The 32RE Group may appoint two out of six directors to the Board of the JV. SLB has committed to contribute a stake of the total fund commitments via the 32RE Group, with the balance capital being raised from other accredited and/or institutional investors. The Group has also undertaken not to conduct, carry on, promote, invest, be concerned or interested in as well as provide financial assistance to certain restrained businesses that may be in direct conflict with the business of the JV during the relevant restricted periods as stipulated in the subscription and shareholders agreement.
