The change in Mr. Thia Peng Heok George's interest is a consequence of the: (i) vesting of 84,000 share awards out of the remaining share awards of 84,000 granted to him on 28 November 2021 pursuant to the Yoma Performance Share Plan (the "Yoma PSP 2015") and approved by shareholders at the Annual General Meeting of the Company held on 29 January 2021. Following the vesting of 84,000 share awards, the total of 250,000 share awards granted to Mr. Thia Peng Heok George on 28 November 2021 pursuant to the Yoma PSP 2015 have been fully vested. (ii) vesting of 408,000 share awards out of the remaining share awards of 408,000 granted to him on 28 May 2023 pursuant to the Yoma PSP 2015 and approved by shareholders at the Annual General Meeting of the Company held on 27 July 2023. Following the vesting of 408,000 share awards, the total of 1,200,000 share awards granted to Mr. Thia Peng Heok George on 28 May 2023 pursuant to the Yoma PSP 2015 have been fully vested. The percentage of shares immediately before the change is calculated based on the total number of issued shares of the Company of 2,401,997,260 shares (excluding treasury shares).
