ALLOTMENT, ISSUE AND LISTING OF NEW UNITS UNDER THE DISTRIBUTION REINVESTMENT PLAN

Ltd., in its capacity as trustee-manager of Croesus Retail Trust (“**CRT**”, and as trustee-manager of CRT, the “**Trustee-Manager**”), wishes to announce that 5,005,533 new units in CRT (“**Units**”) have been allotted and issued at an issue price of S\$0.8345 per new Unit to eligible unitholders of CRT (“**Unitholders**”) who have elected to participate in the distribution reinvestment plan (“**DRP**”) in respect of the distribution of 1.61 Singapore cents per Unit for the period from 4 April 2016 to 30 June 2016 (the “**Distribution**”).

Distribution payments to eligible Unitholders who did not elect to participate in the DRP would have been paid in cash today.

The new Units, which have been allotted and issued today, are expected to be credited as fully paid today.

The new Units will rank *pari passu* in all respects with the existing Units in issue.

Following the issue of the new Units, the number of issued Units has increased to 752,243,221 Units from 747,237,688 Units.

The new Units will commence trading on the Main Board of Singapore Exchange Securities Trading Limited (the “**SGX-ST**”) at 9.00 a.m. today.
