 - (b) any material factors that affected the cash flow, working capital, assets or liabilities of the Group during the current financial period reported on.

8(a) Material factors that affected turnover, costs and earnings

Revenue

For 2Q2018, the Group registered a revenue of S\$30.8 million compared to S\$29.8 million during 2Q2017. For HY2018, the Group registered a revenue of S\$56.2 million compared to S\$55.1 million during HY2017.

The revenue mainly consists of below segments:

General segment

For 3 months ended, revenue from the general segment (where customers include home-owners, architecture, interior design and renovation firms) increased by \$\$3.6 million or 23.8% from \$\$15.1 million during 2Q2017 to \$\$18.7 million during 2Q2018 at the back of a more active property resale market. For HY2018, revenue from general segment increased by \$\$5.6 million or 20.7% from \$\$27.1 million during HY2017 to \$\$32.7 million during HY2018.

Project segment

For 3 months ended, revenue from the project segment (where customers include architecture firms, property developers and construction companies) decreased by \$\$2.5 million or 17.9% from \$\$14.0 million during 2Q2017 to \$\$11.5 million during 2Q2018. For HY2018, revenue from project segment decreased by \$\$4.6 million or 17.2% from \$\$26.8 million during HY2017 to \$\$22.2 million during HY2018. The project segment continued to be affected by the slowdown of private sector construction activities since 2017.

Interest Income

This pertains to a loan of US\$1 million (equivalent to approximately S\$1.3 million) to an associate, Viet Ceramics International Joint Stock Company ("VCI"), to support their business expansion in Vietnam.

Other Gains

For 2Q2018, other gains mainly comprised of fair value gain on derivative financial instruments of \$\$0.2 million and compensation received of \$\$0.1 million. For HY2018, other gains mainly comprised of fair value gain on derivative financial instruments of \$\$0.2 million, compensation received of \$\$0.1 million and government grant income, such as those from wages credit scheme and special employment credit, amounting to \$\$0.1 million.

For 2Q2017, other gains mainly comprised of fair value gain on derivative financial instruments of S\$0.4 million. For HY2017, other gains mainly comprised of foreign exchange adjustment gains of S\$0.1 million and government grant income, such as those from wages credit scheme and temporary employment credit of S\$0.1 million.

Purchase of inventories are mainly denominated in United States Dollar (USD) and Euro. The Group entered into foreign currency forward contracts to hedge against fluctuations of exchange rates in USD and Euro. These are binding contracts in the foreign exchange market that locks in the exchange rate for the purchase or sale of a currency on a future date. The difference between foreign currency forward contract rates and forward market rates as at period end date would then be recorded under 'Other Gains' or 'Other Losses'.

Other Losses

For 2Q2018 and HY2018, other losses mainly comprised of foreign exchange adjustments losses of S\$0.2 million and S\$0.3 million respectively.

For 2Q2017, other losses mainly comprised of foreign exchange adjustments losses of \$\$0.5 million. For HY2017, other losses mainly comprised of fair value losses on derivative financial instruments of \$\$0.3 million.

8(a) Material factors that affected turnover, costs and earnings (Continued)

Cost of Sales

Cost of sales is computed based on purchases and related expenses net of changes in inventories of finished goods for the respective financial years.

For 3 months ended, cost of sales decreased by \$\$0.2 million or 1.0% from \$\$17.5 million during 2Q2017 to \$\$17.3 million during 2Q2018. For HY2018, cost of sales decreased by \$\$0.3 million or 1.2% from \$\$32.4 million during HY2017 to \$\$32.1 million during HY2018.

The gross profit margin (based on revenue from sale of goods (excluding rental and other income) and cost of sales, without taking into account labour costs and overheads) of 42.7% for 2Q2018 (HY2018: 41.6%) has slightly improved as compared to 40.9% for 2Q2017 (HY2017: 39.9%).

Employee Benefits Expense

For 3 months ended, employee benefits expenses increased by \$\$0.3 million or 6.4% from \$\$4.5 million during 2Q2017 to \$\$4.8 million during 2Q2018. For HY2018, employee benefits expenses increased by \$\$0.5 million or 5.8% from \$\$8.9 million during HY2017 to \$\$9.4 million during HY2018. As at 30 June 2018, the Group had 343 employees (including directors) (30 June 2017: 324).

The increase was mainly due to annual salary increment with effect from July 2017, overtime expenses, changes in commission package and increase in headcount to cope with the increased volume of business of the Group.

Amortisation and Depreciation Expense

For 3 months ended, amortisation and depreciation expenses remain constant during 2Q2017 and 2Q2018 at S\$1.5 million.

For half year ended, amortisation and depreciation expenses remain constant during HY2017 and HY2018 at S\$3.0 million.

Impairment Losses

The impairment losses during 2Q2018 mainly comprised of allowance for impairment of inventories of S\$0.2 million and provision for doubtful debt of S\$0.1 million. For 2Q2017, the impairment losses mainly comprised of allowance for impairment of inventories and provision of doubtful debt for trade receivables of S\$0.4 million and S\$0.1 million respectively.

The management assesses the collectability of trade receivables regularly, considering various factors such as financial status of the Group's customers and age of trade debts. Impairment on specific trade receivables would be made if the chance of recovery is very low.

Impairment of inventories is assessed quarterly considering the age of inventory items and prevailing market demand of inventory category.

For 3 months ended, impairment losses decreased by \$\$0.2 million or 35.3% from \$\$0.5 million during 2Q2017 to \$\$0.3 million during 2Q2018. For half year ended, impairment losses remain constant at \$\$0.8 million during HY2017 and HY2018.

Finance Costs

For 3 months ended, finance costs increased by \$\$0.1 million or 17.1% from \$\$0.9 million during 2Q2017 to \$\$1.0 million during 2Q2018. For HY2018, the finance costs increased by \$\$0.3 million or 15.5% from \$\$1.7 million during HY2017 to \$\$2.0 million during HY2018. The increase in finance costs was mainly due to increase in interest rates.

Other Expenses

For 3 months ended, other expenses decreased by \$\$0.2 million or 5.5% from \$\$2.7 million during 2Q2017 to \$\$2.5 million during 2Q2018. For HY2018, other expenses had decreased by \$\$0.6 million or 11.0% from \$\$5.7 million during HY2017 to \$\$5.1 million during HY2018.

The decrease in other expenses were mainly attributable to the cessation of rental of a warehousing space in Changi North Way in March 2017 and July 2017 as the Group relocate to the new warehouse owned by a subsidiary located at 18 Sungei Kadut Street 2 Singapore 729236 (World Furnishing Hub).

Share of Profit from an Equity-Accounted Associate

For 3 months ended, share of profit from associate, VCI, amounted to S\$0.4 million (2Q2017: S\$0.8 million). For HY2018, share of profit from associate, VCI, amounted to S\$0.8 million (HY2017: S\$1.3 million) under the backdrop of a positive economic climate and high level of construction activities in Vietnam.

Share of Losses from Equity-Accounted Joint Ventures

In November 2017, the Group incorporated and took a 50% equity interest in a joint venture company, Guangdong ITA Element Building Materials Co., Limited ("ITA Element") with its capital injection of RMB15,000,000 (Equivalents S\$3.1 million). The investment in ITA Element is part of the Group's growth strategy to enhance its regional presence.

For 3 months ended, share of losses from joint ventures amounted to S\$0.1 million (2Q2017: Share of profit of S\$14,000). For HY2018, share of losses from joint ventures amounted to S\$0.3 million (HY2017: S\$0.2 million).

Profit Before Income Tax

For 3 months ended, profit before income tax increased by S\$0.8 million or 26.0% from S\$3.0 million during 2Q2017 to S\$3.8 million during 2Q2018. For HY2018, profit before income tax increased by S\$1.0 million or 27.5% from S\$3.5 million during HY2017 to S\$4.5 million during HY2018.

Excluding share of profits from associate and joint ventures amounting to S\$0.3 million (2Q2017: S\$0.8 million), profit before income tax generated from recurring activities was S\$3.5 million for 2Q2018 (2Q2017: S\$2.2 million). For HY2018, excluding share of profit from associate and joint venture amounting to S\$0.5 million (HY2017: S\$1.1 million), profit before income tax generated from recurring activities was S\$4.0 million (HY2017: S\$2.4 million).

The higher profit before income tax generated from recurring activities during 2Q2018 and HY2018 was largely due to the increase in gross profit and decrease in other expenses. These increase is partially offset by increase in employee benefits expenses and finance costs.

Other Comprehensive Income (Loss)

This pertained to foreign exchange difference on translating foreign operations.

Income Tax Expense

The current tax expense is based on the statutory tax rates of the respective countries in which the Group operates and takes into account non deductible expenses and temporary differences. Income tax expense was higher in 2Q2018 and HY2018 because of higher taxable profits.

8(b) Material factors that affected cash flow, working capital, assets or liabilities

Non-Current Assets

Non-current assets decreased by S\$1.3 million or 1.0% from S\$135.4 million as at 31 December 2017 to S\$134.1 million as at 30 June 2018.

Property, plant and equipment decreased by \$\$1.9 million or 1.8% from \$\$111.2 million as at 31 December 2017 to \$\$109.3 million as at 30 June 2018. These decreased is mainly due to depreciation expense amounting to \$\$2.9 million which was partially offset by the addition of plant and equipment amounting to \$\$1.0 million during the period.

Other asset (land use rights) pertains to leasehold land in Foshan, China.

The increase in investment in associate amounting to S\$0.9 million pertained to shares of profits amounting to S\$0.8 million from VCI and exchange differences on translating associate with foreign operation amounting of S\$0.1 million.

The decrease in investment in joint venture amounting to \$\$0.2 million pertained to share of losses of \$\$0.3 million and partially offset by exchange differences on translating joint venture with foreign operation amounting to \$\$0.1 million.

Investment property at carrying value of S\$4.2 million pertains to 532 Balestier Road Singapore 329859.

Other financial assets pertain to the Group's investment in shares of SMJ International Holdings Limited (Listed on SGX Catalist) and a tile wholesale company in China.

Current Assets

Current assets increased by S\$4.8 million or 5.0% from S\$95.1 million as at 31 December 2017 to S\$99.9 million as at 30 June 2018

The increase was mainly due to increase in inventories amounting to S\$3.0 million, trade and other receivables amounting to S\$0.7 million, increase in cash and cash equivalent amounting to S\$0.7 million and other assets by S\$0.4 million.

Other assets pertained to advance payment to suppliers, deposits to secure services and prepayments.

As at 30 June 2018, derivative financial assets amounting to \$\$8,000 pertained to fair value gain on outstanding foreign currency forward contracts (31 December 2017: derivative financial liabilities of \$\$0.2 million). Purchase of inventories are mainly denominated in United States Dollar (USD) and Euro. The Group entered into foreign currency forward contracts to hedge against fluctuations of exchange rates in USD and Euro. The difference between forward contract rates and the forward market rates may resulted in fair value gain or loss. This fair value gain or loss will be recorded in profit or loss under other gains or other losses and correspondingly recorded as a current asset or current liability in statement of financial position.

Trade receivables turnover as at 30 June 2018 is 99 days compared to 102 days as at 31 December 2017. Inventory turnover day as at 30 June 2018 is 291 days compared to 273 days as at 31 December 2017.

Non-Current Liabilities

Non-current liabilities decreased by \$\$1.7 million or 1.9% from \$\$87.5 million as at 31 December 2017 to \$\$85.8 million as at 30 June 2018. The decrease is due to repayment of loans during the period.

Current Liabilities

Current liabilities increased by S\$3.6 million or 4.4% from S\$82.0 million as at 31 December 2017 to S\$85.6 million as at 30 June 2018.

The increase was mainly attributable to the increase in other financial liabilities by \$\$3.7 million and trade and other payables by \$\$0.8 million. The increase was partially offset by the decrease of other liabilities of \$\$0.7 million and derivative financial liabilities of \$\$0.2 million.

Total amount of trade payables and trust receipts and bills payable to banks was \$\$34.7 million (31 December 2017: \$\$32.1 million). The turnover of the aforesaid items (based on cost of sales) is 186 days as at 30 June 2018 compared to 171 days as at 31 December 2017.

The increase in other financial liabilities was mainly due to increase in trust receipts and bills payable to banks by \$\$0.8 million and net of repayment of finance lease liabilities, bank loans and loan drawdown amounting to \$\$2.9 million during the period.

The decrease in other liabilities was mainly due to decrease in advance payment received from customers.

Other Reserves

This pertain to foreign exchange difference on translating foreign operations.

Cash Flows Review

2Q2018

Net cash flows from operating activities was \$\$1.8 million due to operating cash flows before working capital changes of \$\$5.9 million and net cash flows used in working capital of \$\$3.6 million and income taxes paid of \$\$0.5 million. The net cash flows used in working capital of \$\$3.6 million was mainly attributable by increase in inventories, trade and other receivables and other assets by \$\$2.1 million, \$\$1.9 million and \$\$1.1 million respectively together with decrease in derivative financial liabilities and other liabilities by \$\$0.2 million and \$\$0.3 million respectively. This was partially offset by the increase in provision of \$\$0.2 million and increase in trade and other payables of \$\$1.8 million.

Net cash flows used in investing activities amounting to S\$0.5 million for 2Q2018 was mainly attributable to cash outflow for purchase of property, plant and equipment.

Net cash flows used in financing activities amounting to S\$0.8 million for 2Q2018 was mainly attributable by the dividend paid to equity owners and non-controlling interests of S\$2.4 million, repayment of interest expenses of S\$1.0 million and repayment of bank loan and finance lease liabilities of S\$2.2 million.

This was partially offset by the following:

- a) Proceeds from new bank loan of S\$3.5 million; and
- b) Increase in trust receipts and bills payable of S\$1.3 million.

As a result of the above, there was a net increase of \$\$0.5 million in cash and cash equivalents for 2Q2018. Cash and cash equivalents as at 30 June 2018 was \$\$6.7 million.

HY2018

Net cash flows from operating activities was \$\$5.9 million due to operating cash flows before working capital changes of \$\$8.9 million and net cash flows used in working capital of \$\$2.3 million and income taxes paid of \$\$0.7 million. The net cash flows used in working capital of \$\$2.3 million was mainly attributable by increase in inventories and other assets of \$\$3.0 million and \$\$0.4 million respectively with decrease in derivative financial liabilities and other liabilities of \$\$0.2 million and \$\$0.7 million respectively. This was partially offset by decrease in trade and other receivables \$\$0.6 million and increase in trade and other payables of \$\$1.4 million.

Net cash flows used in investing activities amounting to \$\$3.1 million for HY2018 was attributable to cash outflow for purchase of property, plant and equipment of \$\$1.8 million and net movements in amount due from an associate of \$\$1.3 million.

Net cash flows used in financing activities amounting to \$\$2.2 million for HY2018 was mainly attributable by the dividend paid to equity owners and non-controlling interests of \$\$2.4 million, repayment of interest expenses of \$\$2.0 million, repayment of bank loans and finance lease liabilities of \$\$3.3 million and decrease in trust receipt and bills payables of \$\$0.8 million.

This was partially offset by the following:

- a) Proceeds from new bank loan of S\$6.2 million; and
- b) Increase in net amount due to related parties of S\$0.1 million.

As a result of the above, there was a net increase of S\$0.6 million in cash and cash equivalents for HY2018. Cash and cash equivalents as at 30 June 2018 was S\$6.7 million.

For 2019 and 2022, BCA expects construction demand to range between S\$26 billion and S\$35 billion each year, with about 60% from public projects and the remaining from private projects.

The Group remains vigilant to market changes and alert to take on any opportunities locally and overseas to grow our business.
