Leveraging EST's expertise in premium smart electric motorcycles design and manufacturing, the partnership will see EST develop and supply a smart electric motorcycle ecosystem ("SEME"). The SEME will encompass the development of electrified small-format mobility, the two-wheel EVs ("E2Ws") and three-wheel EVs ("E3Ws"), equipped with smart riding features as well as supporting systems such as in-house charging stations.

Global sales of electric vehicles (EVs) are increasing mainly due to governments' crack down on emissions, improving charging infrastructure, and innovative battery technologies. According to McKinsey in October 2020, the market for E2Ws and E3Ws was valued at around US\$97 billion, or 4% of global auto sales<sup>1</sup>. By 2022, global sales of E2Ws and E3Ws could reach US\$150 billion and the electrification in the scooter and light-motorcycle segments will accelerate most quickly, especially in emerging markets.
