Shareholding percentage is calculated on the basis of 430,550,000 issued ordinary shares ("Shares") in the capital of Hafary Holdings Limited (the "Company")(excluding treasury shares). In this notice, figures are rounded down to the nearest 0.01% and any discrepancies in aggregated figures are due to rounding.

On 15 March 2022, Mr Low See Ching (the "Offeror"), purchased from Mr Tee Wee Sien 35,574,580 ordinary shares at S\$0.185 per Share (the "Acquisition"). Upon completion of the Acquisition, the Offeror and his concert parties will hold, in aggregate, 38.14% approximately of the total issued capital in the Company. This would have triggered a mandatory general offer (the "Potential MGO") on the part of the Offeror and his concert parties under Rule 14 of the Singapore Code on Takeovers and Mergers (the "Code").

The majority shareholder of the Company, Hap Seng Investment Holdings Pte. Ltd., who holds 218,790,000 shares in the Company representing approximately 50.82% of the total issued and paid up capital in the Company, had on 4 March 2022 provided an irrevocable undertaking NOT to accept the Potential MGO, if made (the "Written Confirmation"). On 4 March 2022, the Offeror had applied to the Securities Industry Council for a dispensation from the requirement to make the Potential MGO on the basis of the Written Confirmation.

On 9 March 2022, the Securities Industry Council had, among others, waived the requirement for the Offeror to make the Potential MGO subject to, among others, compliance with the conditions set out in Note 3 of the Notes on Dispensation from Rule 14 of the Code and the Offeror disclosing in any announcement that makes reference to the Acquisition the Securities Industry Council's waiver of the requirement for the Offeror to make the Potential MGO.
