THE PROPOSED DISPOSAL OF A SUBSIDIARY, DINING HAUS PTE LTD – UPDATE

Capitalised terms used herein shall, unless otherwise defined, have the same meanings ascribed to them in the Company's announcements dated 21 April 2025, 21 July 2025, 12 August 2025, 3 September 2025, 30 September 2025, 1 October 2025, 30 October 2025, 9 January 2026 and the Company's circular dated 15 September 2025 in relation to the Proposed Disposal.

The Board of Directors (the “**Board**”) of Bromat Holdings Ltd. (the “**Company**”, and together with its subsidiaries, the “**Group**”) wishes to update that the Company has been notified by the Purchaser that he has been declared bankrupt. Following this development, the Company has on 7 August 2026 filed a proof of debt of S\$1,059,719.19 with the official assignee to enforce the Proposed Disposal.

The proof of debt relates to the outstanding balance due from the Purchaser to the Company (the “**Outstanding Balance**”), consisting of the remaining unpaid Consideration of S\$1,000,000, as well as the accrued interest of S\$56,219.19 and other charges of S\$3,500, incurred due to the prolonged delay to the completion of the Proposed Disposal by the Purchaser.

The Company will make further announcements to keep Shareholders informed, as and when there are material updates and developments in respect of the Proposed Disposal.

Shareholders and potential investors of the Company are advised to read this announcement and further announcements by the Company carefully. Shareholders are advised to refrain from taking any action in respect of their securities in the Company which may be prejudicial to their interests, and to exercise caution when dealing in the securities of the Company. In the event of any doubt, Shareholders should consult their stockbrokers, bank managers, solicitors, accountants or other professional advisers.
