ACTUAL CUMULATIVE DISTRIBUTION

*Capitalised terms used herein, unless otherwise defined, shall have the meaning ascribed to them in the announcement of CapitaLand Integrated Commercial Trust dated 6 August 2025 in relation to the close of the private placement (the “**Close of Placement Announcement**”).*

Further to the announcement dated 5 August 2025 titled “Notice of Record Date for Cumulative Distribution and Distribution Payment Date”, CapitaLand Integrated Commercial Trust Management Limited, as manager of CapitaLand Integrated Commercial Trust (“**CICT**”, and the manager of CICT, the “**Manager**”) is pleased to announce that the actual Cumulative Distribution per unit in CICT (“**Unit**”) for the period from 1 January 2025 to 13 August 2025 (being the date immediately prior to the date on which the New Units are issued) is 6.97 Singapore cents which comprises the three components of:

- (a) taxable income distribution of 6.49 Singapore cents;
- (b) tax-exempt income distribution of 0.33 Singapore cents; and
- (c) capital distribution of 0.15 Singapore cents.

Unitholders whose securities accounts with CDP are credited with Existing Units as at **5.00 p.m. on 13 August 2025** (being the Record Date) will be entitled to the Cumulative Distribution that will be paid on or around 18 September 2025. **For the avoidance of doubt, the holders of New Units to be issued pursuant to the Private Placement will not be entitled to the Cumulative Distribution.**

The next distribution following the Cumulative Distribution will comprise CICT’s distributable income for the period from 14 August 2025 to 31 December 2025. Semi-annual distributions will resume thereafter, unless otherwise announced.
